JOHNSTOWN, PA – AmeriServ Financial, Inc. (NASDAQ: ASRV) announced that its Board of Directors declared a \$0.025 per share quarterly common stock cash dividend. The cash dividend is payable August 19, 2019 to shareholders of record on August 5, 2019. This cash dividend represents a 2.43% annualized yield using the July 17, 2019 closing common stock price of \$4.11 and represents an approximate payout ratio of 25% based upon the Company's recently reported second quarter 2019 earnings per share of \$0.10.

AmeriServ Financial, Inc. is the parent of AmeriServ Financial Bank and AmeriServ Trust and Financial Services Company in Johnstown. The Company's subsidiaries provide full-service banking and wealth management services through sixteen community offices in southwestern Pennsylvania and Hagerstown, Maryland. The Company also operates loan production offices in Altoona and Monroeville, Pennsylvania. At June 30, 2019, AmeriServ had total assets of \$1.19 billion, a book value of \$5.84 per common share and a tangible book value of \$5.15 per common share.
